



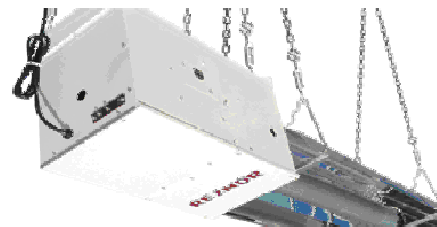

### Warranty Information

For the original owner-user, the Reznor unit will be free from defects in materials or workmanship. This warranty is limited to twelve (12) months from the date of the original installation, whether or not actual use begins on that date or eighteen (18) months from date of shipment by Reznor, whichever comes first. Extended nine (9) year, non-prorated, limited warranty on all tubes. Extended four (4) year, non-prorated, limited warranty on the burner and all electrical and mechanical operating components.
